Agreement and Registration for classes:

I understand the enrollment fee is not refundable. If an emergency arises that causes me to drop out of class I may, with instructor approval and availability of classes, be offered a transfer to a later class. I understand that an occasionally photographs or video footage may be taking of animals that are taken classes from Approved by Dogs LLC. I grant Approved by Dogs LLC. my permission for any resulting photographs or videos of my animal to be used for advertising, or educational materials, understanding that the photographs or video are the sole property of Approved by dogs LLC.

All pets attending group or private courses need to be currently under the supervision of a licensed veterinarian, pre-approved by a licensed veterinarian to take group or private courses healthy and free of communicable diseases at time of service. All dogs must be vaccinated with:

1. at least one, and preferably two, sets of Distemper and Parvo Vaccinations
2. rabies (dogs over 6 months)

\*pets adopted from rescues/shelters should wait 10 days before joining group courses.

These include, with out limitation, risks of physical injury, mental injury, emotional distress, trauma, death, contact with other participants and their dogs and property damage. Because some of the dogs to which I (we) will be exposed may be difficult to control and may be the cause of injury even when handled with the greatest amount of care, I hereby waive and release Approved By Dogs LLC, its officers, employees, owners, and agents from any injury or damage resulting from the behavior of the dog and expressly assume the risk of any such damage or injury while attending any training session or while on the training grounds or the surrounding area thereto.

I shall assume and pay my medical and emergency expenses in the event of injury, illness, or other incapacity regardless of whether I authorized such expenses. In consideration of and as inducement to the acceptance of my application for training, by reading, signing, and dating this document, I hereby agree to indemnify and hold harmless release Approved By Dogs LLC., its officers, employees, agents and or owners of all premises on which these classes are being held for any and all damages to myself my dog or any other dog, losses, fines, suits, expenses, (including attorney fees and defense costs, claims or claims by any member of my family, or any other person accompanying me to any training session or while on the grounds or the surrounding area thereto as a result of any action of any dog, including my own.

**I agree to abide by the policies of Approved By Dogs LLC. Listed below:**

Domestic Dogs: Any dog that is part wild dog and is not 100% domestic dog will not be allowed on the property.

Dangerous Dogs: Any dog which, in the opinion of Approved By Dogs LLC. Is uncontrollable, unpredictable, aggressive, or in any way a danger to people or other dogs will not be allowed in classes. A refund for the remaining classes will be given.

Youth: Anyone 12 to 17 participating in classes must have a parent or responsible adult in attendance at all times. Children under 12 must be accompanied by a non-participating adult at all times while on the premises. Children and visitors are welcome in the viewing area and not on the floor where the classes are taking place.

Dogs on Leash: All dogs must remain on leash when on the premises of the training facilities unless the instructor has approved the dog for off leash training.

No Unsoliciting sniffing: We ask all owners to be aware of their dog's behavior while on leash. All handlers are asked to not allow their dog free access to sniff another person's dog with out asking permission of the owner first.

Humane Treatment: Any person using the facilities used by Approved By Dogs LLC. must agree to use humane training methods that would reflect the Approved By Dogs training philosophy.

Specifically , no shock collars, no ear pinching, no harsh or inhumane treatment of the dogs (including but not limited to hanging , strangling, choking, kicking, dragging, beating, hitting, striking, slamming, throwing or any other pain-inducing method);

Clean Up: All handlers must clean up after their dogs when on the premises of the training facilities and the surrounding area. This includes scooping all solids and using the disinfectant spray in either location inside or outside. This also includes using the disinfectant spray bottles provided for all urination including on any of the equipment and the fencing.

Female Dogs in Heat: Female dogs in heat should not be brought on the grounds or in the facility. Handlers can be re-scheduled into the next available class if this occurs without incurring extra charges.

Class schedules: are subject to be changed and or extended due to conflicts in instructor's schedules, facilities emergencies or weather related cancellations.

## Vaccination Records & Veterinarian release

*Very Important:*

You must send a record of your dog's vaccinations (DHPP and rabies) along with your application. The form below is provided for your convenience; photocopies of current records are also acceptable. Dogs will not be allowed to participate in classes unless proof of vaccination or titers are on file.

All dogs taking classes from Approved By Dogs LLC. must be vaccinated against rabies and against what is commonly referred to as the DHPP combination. Puppies must complete all DHPP vaccinations and their rabies vaccinations before entering the building. Adult dogs should be vaccinated yearly for DHPP and every three years for rabies. Dogs must not be overdue for vaccination when entering the building. Receipts and signed statements from breeders or satisfactory antibody titer levels signed by a licensed veterinarian are acceptable for the DHPP vaccine only.

This dog is of proper age and health to be participating in agility classes or other classes.
